NESS is an educational organization developing the learning mindsets of students in grades K-12, through a unique education model which combines experiential learning with the intentional teaching of the CASEL Social Emotional skill sets. NESS School partnership programs are standards-based and utilize marine sciences and boating platforms to create learning opportunities for all students. NESS is accredited by the New England Association of Schools and Colleges (NEASC), and all programs are mapped to the Next Generation Science Standards (NGSS). These education programs include in-classroom experiences and field trips, as well as on-line experiential learning courses developed by NESS in 2020 as a response to the COVID-19 pandemic.

4b (Code:) (Expenses \$ **836,971** including grants of \$ **31,872**) (Revenue \$ **521,865**)

NESS's Summer Camp includes open enrollment summer programs for students ages 4-17. The programs run for 11 weeks from June-August and are staffed by full time and seasonal educators. Students can register for just one week or for the entire summer. Camp programs comprise a unique experiential learning platform that includes weekly themes, embedded Social Emotional Learning elements, and are designed around age-based levels in sailing, marine science, adventure sports, and powerboating. Summer Camp takes places in Stonington, CT, with some programs in Westerly, RI.

4c (Code:) (Expenses \$ **522,297** including grants of \$ **209,182**) (Revenue \$ **325,662**)

NESS Community programs provide opportunities for community members of all ages to participate in hands-on, experiential programs. NESS offers Adult Sailing and Family Expedition programs. Adult sailing includes beginner and intermediate classes. Family Expeditions allow the entire family to experience a NESS program together. These are done in 3-hour sessions and include marine science and adventure sports options. Other opportunities to experience NESS are harbor tours on either a sailboat or powerboat. Community organizations also partner with NESS to bring educational opportunities to their customers. Finally, as result of the COVID 19 pandemic, NESS continued to offer a Shore Support program in 2021 to assist students and families with the challenges of distance learning.

NESS offers a unique education model that empowers students with leadership, teamwork, confidence, and problem-solving skills to ensure academic success. NESS is the first and only program of its kind to be accredited by New England Association of Schools and Colleges. NESS's STEM-based curriculum includes using marine science, sailing, power boating, and adventure sports as learning platforms. The goal is to increase academic opportunities for K-12 students of all backgrounds in both urban and suburban markets.

NESS's programs are designed to deliberately build students' Social Emotional Learning (SEL) skills and promote the growth of positive learning mindsets. This intentionality results in programs that increase students' confidence, perseverance, self-control, teamwork, and leadership skills, while also building connections between students, their community, and a sustainable natural environment. Evidence demonstrates that learning mindsets are as important, if not more so, to students' academic success than socioeconomic background or schools' performance level.

NESS knows from independent research that NESS programs have a profound impact on building students' SEL skills. A 2019 study, conducted by Goodman Research Group found that (among other similar findings) at NESS 96% of students sampled believed they could do better in school, 93% felt more a part of their class, and 89% described themselves as more interested in what they study in science. The study also suggests that there is ample

evidence that SEL factors directly correlate to academic achievement. NESS continues to invest in outcomes-based research of its programming.

NESS has a significant impact on students' lives - increasing their love of learning, unlocking their potentials, and equipping them with tools for success in life. In fact, research shows that students who participate in NESS's school programs are eight times more likely to show gains in confidence, five times more likely to show gains in perseverance, four times more likely to show gains in teamwork, and demonstrate notable better self-control than other students. NESS is truly a STEM education innovation leader, poised to expand on its organization reputation as a leading entrepreneurial education partner.

The COVID-19 pandemic continued to impact operations in 2021. Education programs, especially in the first half of the year, and fundraising activities were both adversely impacted. NESS continued to offer Online Experiential Learning (OEL) courses and the Shore Support program when many schools were in a Distance Learning mode. NESS is now in the process of exploring options to expand the geographic scope of its education programs in the future.

In the fall of 2021 NESS's Nominations & Governance Committee started a management succession process. This ultimately led to the formal announcement that in June of 2022, Eric Isselhardt, PHD was to become Chief Executive Officer, and NESS's founder, Michael Lobdell, was to become Chair-Elect. Dr. Isselhardt previously successfully served as the Chief Executive Officer of national and international education organizations.
